JCCH'S LARGEST CULTURAL FESTIVAL IS HELD AT THE BEGINNING OF EACH YEAR. THE NEW YEAR'S OHANA FESTIVAL ATTRACTS OVER 5,000 VISITORS TO THE CENTER AND BRINGS TOGETHER THE COMMUNITY TO SHOWCASE JAPANESE DANCE, MUSIC, MARTIAL ARTS, CULTURAL ARTS AND FOOD. OTHER PROGRAMS INCLUDE TANOSHII HAWAII (A CULTURAL YOUTH SUMMER DAY CAMP), HOOHANA COHORT PROGRAM (A COMMUNITY LEADERSHIP PROGRAM TARGETING EARLY CAREER PROFESSIONALS), AND TOMODACHI KIBOU FOR MAUI (PROGRAM TO ENGAGE, INSPIRE AND EMPOWER YOUTH IMPACTED BY THE LAHAINA WILDFIRES).

THE RESOURCE CENTER ALSO PROVIDES ASSISTANCE TO INDIVIDUALS RESEARCHING THEIR FAMILY HISTORIES, TRANSLATION SERVICES OF FAMILY REGISTRIES AND INTERPRETATION OF JAPANESE NAMES.

THE ELLISON ONIZUKAREMEMBRANCE EXHIBIT IN THE HISTORICAL GALLERY IS A TRIBUTE TO HAWAII'S FIRST ASTRONAUT, THE COLLECTION OF PHOTOS AND NASA ARTIFACTS WERE TRANSFERRED FROM STORAGE IN KONA TO THE HISTORICAL EXHIBITION AT JCCH. THE HONOULIULI EDUCATION CENTER, LOCATED IN THE COMMUNITY CENTER, SHOWCASE JCCH'S WORK TO PRESERVE HONOULIULI AND TO FEATURE HISTORICAL ARTIFACTS AND ORAL HISTORIES OF FORMER JAPANESE AMERICANS INTERNED DURING WORLD WAR II.
